Proposed amended guidelines for the BTG committee chairperson

The following bullet is to be added to the Duties and Responsibilities of the BTG committee chairperson in the English and Spanish versions of the guidelines documents:

- For the English version
  - Appoint two members of the BTG committee to attend the Annual Bridging the Gap Weekend Workshop. Appointees may be the BTG Chairperson and Alternate but not necessarily so. Appointees shall attend the Workshop and, subsequently, share their experience with their committee and with the Assembly.
- For the Spanish version
  - Nomina a dos miembros del comité Uniendo las Orillas para que asistan el taller ULO anual que dura un fin de semana. Los nominados pueden ser el presidente del comité ULO y su suplante, pero no tiene que ser estos dos. Los nominados asistirán el taller y, después, compartirán su experiencia con el comité y con la Asamblea.
